Student Loan Reimbursement Program for the Benefit of Employees of Non-Profit Service Organizations in New Haven & Middlesex counties

Requirements & Criteria

Applicants must have earned or be completing graduate degrees and be employed or be promised future employment in a public service non-profit organization in the New Haven and Middlesex county area. Towns included are: Bethany, Branford, Cheshire, Chester, Clinton, Deep River, East Haddam, East Haven, East Lyme, Essex, Guilford, Haddam, Hamden, Killingworth, Lyme, Madison, Meriden, Middlefield, Middletown, Milford, New Haven, No Branford, No Haven, Old Lyme, Old Saybrook, Orange, Southington, Wallingford, West Haven, Westbrook, Woodbridge. Candidates must have previously received need related student loans through such vehicles as the GSLA (Stafford) or NDSL (Perkins) programs during their graduate studies. Applicants may apply nine months prior to graduation and up to two years after graduation. An applicant's annual personal income shall not exceed \$50,000.

The Foundation will reimburse those applicants who are accepted into the program for all or part of their graduate student loan payments every six months for four consecutive periods (2 years) during which the applicant must remain employed by an approved non-profit service organization.

How to Apply

Complete the attached application to apply for a graduate school student reimbursement. Applications are processed on an on-going basis.

The process of recruiting applicants is facilitated by the Community Foundation of Greater New Haven. Interviews are by invitation and are conducted quarterly. Award recipients are selected by the Directors, based on their contributions to the community and financial need. Scholarships are open to anyone who meets the requirements outlined in this brochure, except for REALTORS® and their immediate families.
